

Reply to the query raised by the bidders in pre-bid meeting held on 27.08.2021 at 01.00 pm in the Conference Hall No. II, Bihar Veterinary College, Patna in connection with the tender (NIT No. 07/CPC/BASU/2020-21 dated 05.08.2021) floated for opening of Veterinary Medical Shop in the Veterinary Clinical Complex, BVC, Patna on rent basis.

Following official were present in the Pre-bid meeting:

1. Dr. K.G. Mandal - Director Procurement
Univ. Prof., AGB
2. Dr. Kaushalendra Kumar - Procurement officer
Asstt. Prof., ANN

A total of three persons attended the pre-bid meeting and they have raised the following issues:

- i. Review the timing for opening and closing the medicine shop.
- ii. Requested for the enhancement of area of shop (up to 300 sq. ft.).
- iii. Requested for provision of payment of license fee from university side, if demolition present structure or change of shop location in future.
- iv. Requested for wave off the rent during particular period of time, if any natural disaster/ pandemic notified by the Government and force closure of shop.
- v. Also raise concern on single shop in campus and not opening of any 2nd shop in BVC premises.
- vi. Also needs clarity about the annual increment of rent @ 10% offered in tender.

Answer to the query:

A meeting was held on 03.09.2021 under the Chairmanship of the Dean, Bihar Veterinary College, Patna to resolve the following issues/query raised by the persons participated in the pre-bid meeting:

1. Query for opening and closing time of Medical Shop.

Ans: it was resolved that the Veterinary Medical Shop will remain open from 09:00 A.M. to 05:00 P.M.

2. Query for enhancement of space (up-to 300 sqft.), if required (Size no change).

Ans: Additional space for store cannot be provided.

3. Provision of payment of licence fee from University side, due to demolition of present structure or change of location.

Ans: Not agreed.

4. Request for waive of rent due to forced closer of shop in the event of Natural Disaster/pandemic notified by the government.

Ans: Waive of rent will be done as per University rules.

5. Whether more than one medical shop will be opened in the campus or not.

Ans: In this regards it was resolved that no other Veterinary medical shop will be opened during agreement period.

6. Issues regarding hike of annual increment of rent @ 10% mentioned in the terms & conditions of the tender.

Ans: As per terms & conditions laid down in the tender, there will be increase of rent @ 10% per annum over the previous year.


