1.2 Eligibility Criteria for admission in M.V.Sc. Degree Programme

- A candidate should possess a basic under graduate degree i.e. B.V.Sc. & A.H. in the subject concerned.
- A candidate should possess Bachelor's Degree in the concerned subject (B.V.Sc. & A.H.) with minimum of 60% marks in aggregate or an OGPA of 6 out of 10 in a 10 points scale and 55% in aggregate or an OGPA of 5.5 out of 10 for SC/ST candidates.
- Candidate should have qualified the **ICAR-AIEEA (PG)-2025** in concerned major subject group.
- Admission to Master Degree Programme is open for the Domicile of Bihar state only.**

1.3 Admission Procedure

- Selection of candidate will be made on the basis of **ICAR-AIEEA (PG)-2025 score** followed by counselling by the University. The candidates will have to opt the subject at the time of counselling based on seat availability and reservation policy of Bihar Government.

- b. Merit list shall be prepared for the candidates who apply for admission.
- c. In case of a tie of score, performance at Bachelor's Degree level examination will form the criteria. If performance at the degree level is also equal, then seniority in the age would determine the priority.

Note:

In case the seats under State Quota remain unfilled from the students of Animal Biochemistry as major subject group, eligible candidate from Animal Sciences as major subject group will be given 1st priority and Veterinary Science will be given 2nd priority for admission in the department of Veterinary Biochemistry as per decision of 11th Academic Council of the University.

- b. Candidate should have qualified the **ICAR-AICE-JRF & SRF-2025** in concerned subject.
- c. A candidate can apply for admission to only one subject. No change would be allowed.
- d. **Admission to Ph.D. Programme is open for the Domicile of Bihar state only.**



- a. The minimum qualification for admission to the Ph.D. Program shall be Master's Degree in the subject concerned with at least 70% marks in aggregate or OGPA 7.0/10.0 at the Master's level and is relaxable up to 65% marks in aggregate or OGPA 6.5 out of 10.0 for candidates belonging to SC/ST categories.
- b. Candidate should have qualified the **ICAR-AICE-JRF & SRF-2025** in concerned subject.
- c. A candidate can apply for admission to only one subject. No change would be allowed.

4. General rules of reservation

- 4.1 Rules regarding filling of vacant seats in reserved category shall be followed as per Govt. of Bihar Reservation Rule for admission in educational institution.
- A. Such reserved category candidates who is selected on the basis of his/her merit, shall be counted against the vacancies in the open merit category and not against the reserved category vacancies.
 - B. Woman of Backward Classes means women of all reserved classes and includes women of Scheduled Caste, Scheduled Tribes, Extremely Backward Classes and Backward Classes.
 - C. No other reservation shall be made except reservation percentage granted by the concerned educational institute and amended of reservation percentage granted by them from time to time for the candidates out of Bihar.
 - D. Reserved seats left vacant due to non-availability of concerned reserved category candidates shall be filled in the following manner: -
 - Exchange shall be possible between the Schedule Caste and Schedule Tribes.
 - Exchange shall be possible between the Extremely Backward Classes and Backward Classes.
 - After having completed the procedure contained above, if the reservation percentage of any reserved category is not exhausted then candidates belonging to unreserved category shall be admitted against such vacancy on duly declared it deserved through the administrative department, during the session by the Administrative Department for said session
 - E. In case of non-availability of suitable candidates for the reserved seats for women of Backward classes, the vacancies shall be filled in order of preferences as follows: -
 - ❖ By the candidates of the Schedule Castes.
 - ❖ By the candidates of the Schedule Tribes.
 - ❖ By the candidates of the Extremely Backward Classes.
 - ❖ By the candidates of the Backward Classes.
- 4.2 **For EWS Candidates:** Certificate of Economically Weaker Sections and not possessing any of the assets mentioned in rule 3(2) of **The Bihar Reservation in vacancies in posts and services and in Admissions in the Educational Institutions for (Economically Weaker Sections) Act, 2019** will be issued by District Magistrate/Sub – Divisional Magistrate/Circle Officer concerned in the prescribed format.
- 4.3 **For PWD/Divyang Candidates:** Disability Certificate in prescribed performa issued by the Civil Surgeon/Medical Board indicating the nature and extent (including percentage) of Physical Disability in support of their claim for admission against reserved quota for PwD.

Reservation Category (Abbreviation): UR – Unreserved, EWS – Economically Weaker Section, BC – Backward Class, EBC – Extremely Backward Class, SC – Scheduled Caste, ST – Scheduled Tribe, WBC – Women of Backward Classes.

6. General instruction

6.1 How to Apply

Candidates are required to fill the application form in **CAPITAL LETTERS** only and submit it to **The Registrar, Bihar Animal Sciences University, Bihar Veterinary College Campus, Patna- 800014** along with self-attested copies of educational certificates, supporting documents as specified below and proof of payment so as to reach on or before the last date.

6.2 Certificates required with Application Form

- 6.2.1 Certificate of having passed the qualifying examination along with copy of the marks-sheet/transcript of all the examinations passed.
- 6.2.2 Matriculation certificate as proof of age.
- 6.2.3 Permanent Resident/Domicile certificate of Bihar issued by the competent authority.
- 6.2.4 Copy of score card **ICAR-AIEEA (PG)-2025/ICAR-AICE-JRF/SRF (Ph.D.)-2025** (As applicable).
- 6.2.5 Certificate of Character from the Head of last Institution attended and also another one from a Gazetted Officer or a College or University teacher not related to the candidate, but intimately known to the candidate.
- 6.2.6 Certificate of Physical fitness from a Registered Medical Practitioner.
- 6.2.7 The candidates under reserved category, i.e. EWS, BC, EBC, SC, ST and Divyang shall attach the required certificate in the prescribed format issued by a competent authority in support of their claim without which their claim will not be considered.
- 6.2.8 Copy of Aadhar Card.

6.3 Certificates required at the time of Counseling

- 6.3.3 Six sets of recent passport size color photographs.
- 6.3.4 The candidates enjoying employed status and selected for admission to any programme of study in the University, are required to produce LEAVE SANCTION /RELIEVING ORDER AT THE TIME OF ADMISSION/REGISTRATION from their employer for the duration of the programme permitting them to pursue their studies at the University, failing which the offer of admission shall stand withdrawn. In case of any dispute the decision of the University shall be final.
- 6.3.5 The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- 6.3.6 Any candidate failing to appear in the counseling shall not be considered for admission. No TA/DA is admissible for appearing in the counseling.

6.4 Other Terms and Conditions

- 6.4.1 The University reserves the right to make addition or deletion in number of seats without any notice.
- 6.4.2 The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the concerned course of study; if it is found that the candidate has/had produced fake/forged certificate(s)/ documents(s), indulged in any act of misconduct/indiscipline and has/had concealed any other relevant information at the time of seeking admission.
- 6.4.3 The selected candidates must have to submit the undertaking regarding not to indulge in any kind of raging and other in-disciplinary activities at the time of Registration/Admission.
- 6.4.4 The admission of the candidate to the concerned Course of Study shall be subject to such ordinances, rules and regulations as framed time to time by the University.
- 6.4.5 The Category (UR/EWS/BC/EBC/WBC/SC/ST/PwD) declared by the candidate in application form will be final. No subsequent change will be allowed. Reservation of seats shall be given as per the Policy of the Government of Bihar.
- 6.4.6 In case of any disputes, suites or legal proceedings against the University, the territorial jurisdiction shall be restricted to the Courts in Bihar at Patna only.
- 6.4.7 Candidates are advised to regularly keep visiting the University website for latest updates in this respect.

6.5 Modalities for admission under additional seat in Master's and PhD programme for outside state in different faculties/constituent colleges of Bihar Animal Sciences University, Patna

- 6.5.1 **Number of Seats for admission in master's/ PhD degree programme under other state quota**
One seat in each department (in addition to exiting seats for the candidate of resident of Bihar and ICAR quota) shall be available for candidates from outside state of Bihar. No reservation will be applicable to candidates from other states. These candidates shall not be entitled for any state sponsored fellowship/ stipend.

6.5.2 Eligibility for Admission

6.5.2.1 Master's Degree Programme

The minimum academic attainment for admission to Master's Degree Programme of the University shall be as follows: -

- (i) A candidate should possess a basic degree U.G. i.e. B.V.Sc. & A.H. or B.Tech or B.F.Sc in the subject concerned.
- (ii) For getting admission to Master's programme, the merit will be determined on the basis of the criteria laid down by the P.G. Faculty and Academic Council subject to the following conditions:

- (a) A candidate should possess Bachelor's Degree in the subject concerned with minimum of 60% marks in aggregate or an OGPA of 6 out of 10 in a 10 point scale and 55% in aggregate or an OGPA of 5.5 out of 10 for SC/ST candidates.
- (b) Merit will be determined on the basis of rank/marks obtained in Entrance examination for M.V.Sc., M.Tech., M.F.Sc. and Ph.D. Admission test as mentioned in RRI of BASU.
- (c) A candidate selected for admission to Master's Degree Programme would be allowed to exercise option of discipline in the concerned stream in which he/she has appeared in the Entrance Examination.
- (d) A student admitted to the Post-graduate Programme may be required to take deficiency courses, if any, prescribed by the Chairman/HoD and Advisory Committee, in addition to the courses required as per regulation.

6.5.2.2 Ph.D. Degree

The minimum qualification for admission to the Ph.D. Programme shall be Masters' Degree in the subject concerned with at least 70% marks in aggregate or OGPA 7.0/10.0 at the Masters' level and is relax able of SC/ST up to 65% marks in aggregate or OPGA 6.5 out of 10.0 for candidates belonging to SC/ST categories.

6.5.3 Mode of Selection

A separate call of admission in Master's and PhD programme in different departments under other state quota shall be notified in the admission bulletin/ prospectus for admission in BASU, Patna. Merit list of the candidate for admission under this quota will be notified separately for candidates belonging to states other than Bihar.

6.5.3.1 Master's Degree

Admission in Master's Degree Programme shall be made on the basis of merit of AIEEA (PG) Examination conducted by ICAR followed by counselling by the University.

6.5.3.1 Ph.D. Degree Programme

Admission in Ph.D. Degree Programme shall be made through merit/score of AICE (Ph.D.) Examination conducted by ICAR followed by counselling by the University.

6.5.4 Admission of Students

6.5.4.1 Certificates required with application: -

- (i) Certificate of having passed the qualifying examination together with copy of the marks-sheet/transcript of all the examinations passed.
- (ii) Matriculation certificate as proof of age.
- (iii) Certificate of Character from the Head of the Institution last attended and also another one from a Gazetted Officer or a College or University teacher not related, but intimately known to the candidate.
- (iv) Certificate of Physical fitness from a Registered Medical Practitioner.
- (v) A Migration and/or Transfer Certificate in case of the candidate migrating from a University other than Bihar Animal Sciences University, Patna, Bihar.
- (vi) A college leaving certificate from the institution last attended.


6.5.5 Notification of Merit List for Selection under other state quota




